Participants: Students and Researchers of History and all those interested in History.

Course contents, contact hours, teaching and evaluation:

The focus of the course will be to introduce learners to some significant textual traditions pertaining to early India, which continue to arouse widespread interest at present. Necessarily selective, the attempt will be to provide a sense of the diversity and richness of these traditions. Questions that will run through the course will include those of the authorship and chronology of the texts, the intended audiences, the ways in which they were transmitted and preserved, the issues that were represented, strategies of representation and the social milieus in terms of which they may be contextualised.

Outline histories of early India may be used as background material for the course. The following two works are recommended as background reading:

Romila Thapar, *Early India: From the Origins to AD 1300*, London, Allen Lane, 2002.

Upinder Singh, *A History of Ancient and Early Medieval India*, New Delhi, Pearson, 2008.

The course will consist of seven interactive lectures of two hours each, and an open book assessment exercise of one hour.

Questions that will run through the course will include those of the authorship and chronology of the texts, the intended audiences, the ways in which they were transmitted and preserved, the

issues that were represented, strategies of representation and the social milieus in terms of which they may be contextualised.
