INSTRUCTIONS FOR NET QUALIFIED CANDIDATES-JUNE 2016

- 1. The Supervisor/Guide/Fellowship awarding Authority/Lectureship appointing Authority Viz. University/Instt. must verify the original record/certificates including the CGPA Conversion/Percentage and recognition of the University/Instt. of the candidate regarding eligibility criterion & caste/PH/VH certificate (if applicable) for this test while considering him/her for fellowship/appointment, as CSIR is not responsible for the same.
- 2. Extract of Eligibility Criterion as laid down in the Notification No.10-2-(5)/2016(i)-E.U.II published in Employment News dated 6th 12th February, 2016 for this examination:
- (a) EDUCATION QUALIFICATION: M.Sc or equivalent degree/ Integrated BS-MS/BS-4 years /B.E./B.Tech/B.Pharma/MBBS with at least 55% marks for General and OBC (Non Creamy Layer) candidates (Central list only as provided in National Commission for Backward Classes website www.ncbc.nic.in) and 50% for SC/ST candidates, Physically and Visually Handicapped candidates.

The eligibility for Lectureship of NET qualified candidates will be subject to fulfilling the criteria laid down by UGC. Ph.D degree holders who have passed Master's degree prior to 19th September 1991, with atleast 50% marks are eligible for lectureship only.

The education qualification criteria as notified by CSIR in the Employment News/CSIR HRDG website (www.csirhrdg.res.in).

(b) AGE LIMIT & RELAXATION:

- (i) <u>JRF(NET)</u>: Maximum 28 years as on 01.01.2016 (relaxation in upper age up to 5 years for candidates belonging to SC/ST/OBC(Non Creamy Layer) Central List /PH/VH/Female candidates).
- (ii) <u>LECTURESHIP (NET)</u>: No upper age limit for Eligibility for Lectureship category.
- 3. SC/ST/OBC/PH/VH certificates should be as per CSIR notification (Para 5.3).
