The University of Porto, as coordinating institution of the **MOBILE UNLIMITED** project, financed by the European Commission within the framework of the "Erasmus +", informs that Jeanette Camilla Barbosa Noronha has been selected and awarded a scholarship for a Master (mobility) of 5 months between 2019-09-09 and 2020-02-07 at Universidade do Porto, Portugal.

The scholarship comprises:

- a payment of 850 EUR transferred monthly starting on the date of arrival, which will cover expenses of accommodation, subsistence and every other cost related to the stay at the host institution;
