

Seminar on The "Role of NBA, AICTE, UGC and NAAC in regulating Technical Education"

BACKGROUND

In the last ten years, many Universities and deemed Universities have started offering M.Tech program in Computer Science/IT. By virtue of being University, these institutions do not apply for AICTE affiliation. However, as per the AICTE regulation, a college which is affiliated to a University, has to apply for AICTE affiliation and also take permission from the affiliating University before starting any technical program. In the past, this matter was contested in the court of law and there has been a clear verdict on the matter from the Supreme Court. AICTE in its notification has also made it amply clear that Universities do not have to apply for AICTE affiliation for starting a technical program.

OBJECTIVE

In spite of the AICTE notification, there seem to be some confusion amongst the institutions, faculty members and the students, on AICTE recognition. Many Engineering Colleges are refusing to employ candidates with M.Tech qualification for faculty position because Universities from which they have passed the degree do not have AICTE recognition. In order to have some clarity on the matter, a one day seminar cum debate is being organized by Goa University. The objective of the seminar is to deliberate on the role of NBA/AICTE vis-à-vis University/NAAC in regulating technical education.

WHO SHOULD ATTEND

All Principals and Heads of Computer Science and Engineering program of colleges affiliated University offering BE/B.Tech programs. Students and Faculty members of University and Colleges offering MCA/M.Tech programs. Vice Chancellor, Registrar, Director of Technical Education, Director Higher Education, Director NITTTR, Director NIT Goa, Director BITS Goa, Chairman GPSC and select IT professionals from the industry shall be special invitees. Apart from presentations by invited speakers from regulatory bodies such as NBA, AICTE, UGC and NAAC, there shall be a panel discussion where the participants attending the seminar would be given an opportunity to express their views and also take part in the deliberations that follow.

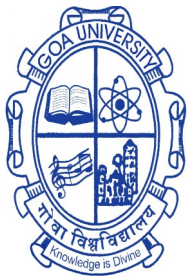
